1	The total number of sections of the school shall be restricted to 8. Any further increase shall require prior approval of the Board subject to compliance with affiliation by laws and availability of rooms of 500 sq. ft. dimension.
2	The boundary on the right side of the school is below 6 feet. The school should construct the boundary wall with a height of 6 feet on all sides and submit the compliance on SARAS portal within 3 months.
3	The school proposes to run a Hostel in the same campus. The Hostel should be cordoned off from the school building. The circular no. 24 dated 01/09/2023 on guidelines for Residential schools should be followed and submit the compliance on the SARAS portal within 3 months.
4	CwSN toilets were shown only on the ground floor. The school should construct CwSN toilets separately for boys and girls as per specifications prescribed by the RPWD Act 2016 and submit the compliance through a videography on SARAS portal within 3 months.

6	The school should conduct training of teachers with CoE Bengaluru and submit the compliance.

Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.
